### **Employer's Quarterly Report Instructions for Regular Taxed ...**

Employers subject to section 4980H of the Internal Revenue Code ("Code"), generally meaning employers with 50 or more full-time employees (including full-time equivalent employees) in the preceding calendar year, use Form 1094-C, Transmittal of Employer-Provided Health Insurance Offer and Coverage Information Returns, and Form 1095-C, Employer-Provided Health Insurance Offer and Coverage ...

### **Form 941-X: Adjusted Employer's QUARTERLY Federal Tax ...**

Employers with only domestic employees have the option to submit their quarterly reports annually. Domestic employers who report wages and pay taxes annually can use the online Unemployment Tax Services system to submit their tax reports and payments electronically. Only employers who have an approved hardship waiver on file with TWC may download the form and mail it in.

New York NYS-1/NYS-45. NYS-1: If you withhold \$700 or more during a calendar quarter you must remit the tax with Form NYS-1, Return of Tax Withheld, within 3 or 5 business days after the payroll report that caused the accumulated tax withheld to equal or exceed \$700.. NYS-45: All employers required to withhold tax from wages must file Form NYS-45, Quarterly Combined Withholding, Wage Reporting ...

The forms below are used to indicate special tax options: Domestic Employer's Election Form - (Form C-20) indicates election by a domestic-only employer to report quarterly wages and pay taxes on an annual basis.; Domestic Employer's Revocation Form - (Form C-20F) revokes a previous election by a domestic-only employer to report quarterly wages and pay taxes on an annual basis.
